

Welcome to Nevada Grand Assembly 2012!

The Housing and Registration forms will seem familiar to you. It is important that the information is as accurate as possible. **DEADLINE IS MAY 1, 2012.**

**Please make sure all dietary needs are clearly defined at the bottom of the registration form at the time of registration.**

**Explanation of the Registration Form:**

- 1) **Name** of person to be registered.
- 2) Their **Title** or Affiliation.
- 3) **Registration:** \$20.00 per person (Any one attending a closed session, including Grand Cross Ceremony/Luncheon or Grand Banquet must pay the Registration Fee. If you are a visiting Supreme Family member, a visiting GWA, or a visiting Grand Representative of Nevada, you do not need to pay the Registration Fee – PLEASE mark "Guest" in that square.)
- 4) **Grandie Party: \$15.00.** *This activity must be paid for by all attendees except Grand Officers and Personal Pages.* Grand Deputies, Directors, the Grand Assembly Committee and others who must be at Grand Assembly on Friday may attend.
- 5) **Saturday Practice Lunch:** \$16.00 per person. This lunch is ONLY for those attending practice session. (Grand Officers, Grand Deputies, Directors, Sound Team, GAC members optional)
- 6) **Saturday Fun Night:** \$16.00 per person. Open to everyone! **PLEASE note dinner will be served from 6 to 7:00 pm; Fun Night will conclude by 8:30 pm.**
- 7) **Sunday Grand Cross Lunch:** \$20.00 per person. 2012 Designees must attend this lunch. All Masters of the Grand Cross are encouraged to attend.
- 8) **Sunday Box Dinner:** \$16.00 per person. Will be available for pickup after the session ends on Sunday. Open to everyone!
- 9) **Monday All Member General Lunch:** \$16.00 per person. Open to everyone!
- 10) **Monday Grand Banquet:** \$22.00 per person. Be sure your Grand Officers' escorts have dinner tickets and are registered through your Assembly. Open to everyone!
- 11) **Noah Breakfast:** \$18.00 per person. This breakfast is being "hosted" by NOAH (Nevada Oldies Are Helping). All adults are welcome and encouraged to attend. NOAH will pay for Nevada Rainbow Girls taking their Majority on Tuesday Morning.

12) **Tuesday Practice Lunch:** \$16.00 per person. This lunch is for ALL current Grand Officers; 2012 New Grand Officer Appointees will be assessed this fee through their "Pins/Presentations" fees by the Supreme Inspector. *Please do not register for this lunch in anticipation of receiving a Grand appointment.* All others who need to be at Installation practice should pay for this lunch (with the exception of Installing Officers from other Grand Jurisdictions).

13) **Water:** Due to restrictions by Peppermill Hotel Casino Spa, all water must be pre-ordered for delivery upon arrival. It is **STRONGLY** recommended that a minimum of five (5) bottles be purchased for each attendee.

14) **2012 Mascot T-Shirts:** \$10.00 each. Please mark the size.

15) **Change/Late Fees:** The charge is \$5.00 per person per change – limited to Nevada Rainbow. Registrations received after the May 1, 2012 deadline will be assessed a \$5.00 per person late fee.

Posters: The Grand Assembly Committee has set the following guidelines for Assembly posters:
